SUBJECT: **Request for Comments at Step 6 on the draft Guidelines on Performance Criteria for Methods of Analysis for the Determination of Pesticide Residues in Food**

DEADLINE: **3 April 2017**

BACKGROUND

1. The 48th Session of the Committee on Pesticide Residues (April 2016) considered the Guidelines and made a number of editorial changes to improve the accuracy and clarity of the document as well as to remove references to documents other than those adopted by the Codex Alimentarius Commission or developed by international organisations.
2. Delegations generally supported the revision and good progress made throughout the document. A number of delegations however requested additional time to consult internally with their experts and other relevant stakeholders in order to fully assess the technical requirements in the Guidelines. It was noted that this was a particular sensitive issue for developing countries and thus the Guidelines should not jeopardise the laboratory capacity for the determination of pesticide residues in these countries.
3. The Committee noted general agreement on the Guidelines. However, in light of the changes made to the document, the Committee agreed to reconsider the Guidelines at its next session for completion and final adoption by the 40th Session of the Codex Alimentarius Commission (July 2017). This would allow broad national consultation between various stakeholders taking into account the relevance of this document for the determination of pesticide residues and its impact on regulatory practices for enforcement of MRLs for pesticides.
4. The Committee therefore agreed to forward the Guidelines for adoption by CAC39 (July 2016) at Step 5.¹
5. The Commission adopted the Guidelines and advanced them to Step 6 for comments².

REQUEST FOR COMMENTS

6. Codex members and observers are invited to submit comments at Step 6 on the draft Guidelines on Performance Criteria for Methods of Analysis for the Determination of Pesticide Residues in Food, as per the general guidance below. The relevant document is the report³ of CCPR48 i.e. [REP16/PR](#), Appendix XI.
7. Based on the discussion held at CCPR48, Codex members are invited to fully assess the technical requirements in the Guidelines and its impact on regulatory practices for enforcement of maximum residue limits for pesticides. In this framework Codex members should identify key provisions that may need further discussion or refinement in order to finalize the Guidelines at CCPR49 (April 2017) and to ensure wide application of the provisions by Codex member countries.

12. At the end of the commenting period, the host country secretariat (China) will compile comments in a relevant working document using the system.
